3. Year 3 Annual Report Template:

- Submit to EPA and you can send Deb a copy as well.

- We did so well last year, let's do that again this year.
- Webinar is September 14th from 10-11. It's the same presentation as August 3rd, but the questions will be different.

4. Winter Maintenance:

- Ted will be invited to a meeting in November or December.
- Gretchen Young from Dover will be at the symposium talking about brine.
- It is not too late to sign up. The registration link is in the agenda.
- Annual Salt Usage Reports are due for permittees that fall under Appendix F & Appendix H for Chloride. Recommended but optional for all others. Due September 15th.
- There are two options for filling this out. The links are on the Blog.
- The first option is a Word form. This needs to be submitted to salt@des.nh.gov.
- The second option is the UNH T2 database. The help button is broken, if you need help reach out to Deb or Tom.
- Use one or the other option and do that by September 15.
- These options are for this year only.
- Q- Brandon- If we were submitting to the database can we delete those entries and fill out the form?
 - o NHDES will talk with UNH T2 and follow up.
 - If you have to use both, be sure to mention that in your report.
- Ben had previously mentioned that the EPA template does not say you need to report on salt annually.
- Deb reached out to EPA to inquire, she has not heard back. She recommends using the optional box to report which method you used to report if you are using the EPA template. It is written out in the NH template.
- Q-Ben- On annual reporting in the UNH T2 system, lane miles or surface area were options the first time he went in and the second time that option wasn't available. It seems to be in a different part of the system. Which you'd have to find if lane miles or surface area changes between storms.
 - Deb and Tom will look into it.
 - o Ben decided it was user error.

5. MCM #5 (Section 2.3.6.b) Long-Term Operation and Maintenance:

- Deb presented.
- The Seacoast Stormwater Coalition is working with VHB to create some materials.
- A maintenance and reporting form has been created.
- They are currently working on a guidance document on what to look for and how to use the form.
