1. Introductions: Those in attendance are listed above.

2. Meeting Minutes:

• The February 10, 2022 meeting minutes were approved.

3. Year 4 Requirements:

- Tom Swenson presented.
- Tom brought up the Year 4 Requirements Table.
- Tom went over the Year 4 requirements for MCM 4 through MCM 6.
- Tom clarified that wet weather sampling and System Vulnerability Factors (SVF) are Year 7 requirements, but we are starting them now to be proactive.
- If the box says "municipal specific" that means it's up to the permittee to work on these topics, if the box is in yellow and says "in progress" that means the coalition is working on templates/resources for everyone to use.
- Make sure to track your site inspections throughout the year.
- Check your regulations for green infrastructure.
- Ranking for permittee owned property and infrastructure- this is the hot spots resources that UNH and NHDES created. There will be some ground truthing and GIS work when permittees get to picking a parcel for retrofit.
- Reporting on catch basin cleanings and street sweeping metrics. This has been ongoing for a couple of years.

- Training for employees that work in areas or with materials included in SWPPPs.
- In the annual report, permittees should include any modifications to BMPs, water quality monitoring, etc.
- Lyndsay Butler suggested duplicating the header on each page of the document.
- Poll Question 1- How are you doing with MCM #1 outreach requirements?

5. New & Improved NH MS4 Blog - Coming Soon:

- Tom Swenson presented.
- The MS4 Blog is going to be completely redone.
- This new blog will be on the NHDES website, but it will be an off shoot.
- The main reason for this change is because of security issues on the current platform.
- The current platform has been having issues and goes down sometimes for long periods of time.
- The new platform should be more consistent.
- The new website won't be ready for several months, late spring or early summer is the launch goal.
- It should be a lot more user friendly.
- You won't have to scroll for ages to get to what you want since it will have multiple new webpages for all of the different materials.

6. Winter Maintenance:

- Tom Swenson presented.
- Ted Diers and Aubrey Voelker are working on this.
- Visit the MS4 calendar on the MS4 Blog or the <u>UNH T2 website</u> to view the available trainings.
- Data Driven Maintenance is a two hour course and is free to municipalities.
- Snow Fighters Seminar is \$60 and is a full day course. This is a great opportunity to network and learn from your peers.
- Steve Landry put in a plug for the Annual Salt Symposium which is coming up in September. They are looking at moving the symposium to the NH Motor Speedway in Loudon.

• All attendees will be entered into a raffle to take three laps around the racetrack in the lap car.

7. Construction General Permit (CGP) Resources and Feedback:

- Deb Loiselle presented.
- <u>CGP resources</u> are posted on the NH MS4 Blog.
- The CGP was just renewed last month.
- There is a link to an EPA resource page on the MS4 Blog.
- The webinar recording will be posted on the MS4 Blog when it becomes available.
- The CGP FAQ document is 34 pages, but it's broken down in a clear way that makes it easy to navigate.
- We need to reach out to the construction/developer audience before the end of Year 4.
- The Education and Outreach Subcommittee will be working on creating materials for this next month.
- NHDES is not the permitting authority. NHDES can give guidance, but they will likely guide you to contact EPA region 1. The contact is Michelle Vuto. Her email is <u>Vuto.Michelle@epa.gov</u>.
- The CGP is for disturbance of one or more acres (unless it is regular maintenance).
- Questions for existing project NOI's can be found on page 12 of the FAQ document.
- Deadlines for reporting can be found in a table on page 29 of the FAQ document.
- One of the biggest changes in the new CGP is the definition of a certified inspector. To become a certified inspector, inspectors will now have to take and pass a course. Page 32 of the FAQ document discusses this further.
- EPA will be offering a free training that will likely be held in August.
- There is an exam to become certified. You need an 80% to pass, but you can take it more than once if necessary. Be sure to keep your certification on file.
- There are also third-party courses to become certificated. EPA does not promote one course over another, but those listed on the EPA's website meet the requirements of the program.
- Projects that are started prior to Feb 27, 2023 don't need a certified inspector. There is time to get certified.
- This is not for the MS4 permit. This is the CGP only.
